### Third-party software

The application package contains a compiled version 1.7.7 of the Git content tracker. Gitbox neither links (statically or dynamically) against Git nor uses custom interfaces to interact with it. Git binaries are provided for user convenience only. You can replace bundled binaries with any compatible build of the current version of Git or newer.

### Preamble
